# **Secretary Speaks**

#### Dear Members of the Board of Trustees, Central committee,

Another year has passed in the glorious history of "**Namma VHS**" and once again the time has come to take stock of what we have done over the past one year and I am happy to share with you some of our key achievements during the year. For the patients who seek our help, VHS has continued to provide truly affordable care and has provided the "healing touch" and brought about a smile in many of the patients faces. This has been possible by our dedicated team of consultants, Honorary and empanelled doctors, staff nurses and support staff who continue to work from their heart in the service of the community.

The past year has had its fair share of joys and sorrows for VHS. During the year VHS lost one of its foremost consultants **Prof.Krishnamoorthy Srinivas**, a doyen in the field of Neurology and one of the greatest Neurologists of our times. He has served VHS for over five decades and established the T.S. Srinivasan Institute of Neurology. He will always be remembered for the high professional standards he set for himself and his team. He has left an indelible mark in our minds. **Dr Prema Krishnaswamy**, a renowned Obstetrician & Gynecologist who was associated with VHS for several decades also passed away during the year. On behalf of VHS, I wish to place on record our sincere thanks for their contributions to our institution. They will remain in our minds and hearts forever.

Change, they say, is the only constant thing in life. And indeed VHS is going through a phase of reinventing itself and renewing its pledge to serve the community better. A strategic task force has been established under the leadership of Mr Kasturi Balaji, a Central committee member. This task force has put in significant effort in creating the new road map for "Namma" VHS.

As of March 31<sup>st</sup> 2018, **Prof C.V Krishnaswami**, Chairman TAG-VHS Diabetes Research Centre retired after 51 years of service to VHS. His vision of providing free care for Type 1 Diabetes patients has been a path breaking approach and hundreds of children have benefitted by this service. The journey continues on the path that he and his team have laid for us. I sincerely thank him for the services rendered. The TAG-VHS DRC department has now been renamed as the TAG-VHS Endocrine & Diabetes Centre. On behalf of VHS I extend a warm welcome to Dr Usha Sriram, a senior endocrinologist and her team to take the department to greater heights.

Another milestone we have reached is the establishment of a "**nakshatra**" Centre along with **REACH** to provide free care for tuberculosis. Over 100 patients have been identified and are being treated. With this we have refocused on our roots and rededicated ourselves to the path of our Founder Dr K.S.Sanjivi who laid the foundation for Tuberculosis diagnosis and treatment at VHS.

The upgraded ophthalmology department – **TAG-VHS Retina centre** is doing excellent work in **vitreoretinal** diseases at extremely affordable costs. During the last year, several international papers were published by the Neurosurgery, Neurology and the TAG-VHS DRC departments. We take pride in our DNB programs in Neurosurgery, Obstetrics & Gynecology and General surgery. The students have faired very well and get excellent training at VHS. My deepest regards to the dedicated teachers.

The journey of VHS over the last 60 years would not have been successful but for the support received from our donors and well-wishers. I would also like to thank the **Rotary Club of Madras Metro** for their continuing support to VHS.

The Society has ended up with an excess of expenditure over income by 222.26 Lakh (2016-17:Rs. Rs.336.78 lakh) with a cash deficit of Rs.12.78 lakh (2016-17: Rs. 171.64 lakh).

Donations received by the Society during the year totalled Rs. 392.57 lakh (2016-17 Rs.514.33 lakh), besides Rs.1.76 lakh (2016-17: Rs. Rs.1.97 lakh) by way of individual foreign contributions. The list of donations received as well as particulars of Specific Endowments and details of the Reserve Fund of the Society as on 31 March 2018 are appended.

Out of the above donations, the amount received for Medical Sciences Research activities during the year was Rs.108.35 lakh (2016–17: Rs. 112.29 lakh).

Appended are the Auditors' Report and the Balance Sheet of VHS as on 31 March 2018, and the Income and Expenditure Account of the institution, for the year 2017-18.

#### **SOCIETY'S ACTIVITIES**

The **59**<sup>th</sup> **Annual General Meeting** of the Society was held on 26 September 2017 at VHS. As on 31 March 2018, there were 929 Patrons and 68 Life Members. During the year under report, the Central Committee met 5 times.

The 25<sup>th</sup>Anniversary Celebrations of the Rajaji Centre for De-addiction were celebrated on 3 June 2017 at the Music Academy. The recovered patients with their family members attended the function at which Sri S.P.Balasubramiam, the renowned singer was the Chief Guest. On 12 January 2018 a camp was conducted at Sri Ramakrishna Mutt, charitable dispensary and diagnostic centre at Meyyur, Thiruvallur District where the spouses of addicted persons were addressed.



On 7 July 2017, a camp was conducted by the De-addiction Department for the students at Lady Nye MRTI Special Higher Secondary, Guilders Services, Pallipattu.

An International Conference on Auditory Brainstem Implant Surgery was held between 7<sup>th</sup> to 9<sup>th</sup> Feb 2018 at

the K.S. Sanjivi Auditorium.

On Children's Day a "Free Paediatric Health Check Up" was conducted on 14 November 2017 at the VHS ABHIMANYU BLOCK. The number of children who benefited from the camp was 68.

The Dr.K.S.Sanjivi Memorial Relaxation Centre was inaugurated on by Professor M.S.Swaminathan. Dr. Lion D. S. Ramaiah, a senior citizen contributed it. The facilities available include carrom board, chess and some traditional indoor games. The Centre also has a swing, a meditation area and with greenery nurtured around.



The 10<sup>th</sup> Annual Day of the Cardiology Department with 3rd **Meena Subramaniam Oration** was held on 6 October 2017 at the K.S. Sanjivi Auditorium. Dr.J. Radhakrishnan, IAS, Principal Secretary to the Government Health and Family Welfare Department, Government of Tamil Nadu was the Chief Guest.

#### **5. NEW INITIATIVES**

During the year under report, VHS has entered into significant arrangements with other organizations with similar purposes of charity for extending its umbrella of services.

#### TIE UP with CANCARE

A Memorandum of Understanding has been entered into with CANCARE FOUNDATION, a Public Charitable Trust for the purpose of rendering palliative care to the terminally ill cancer patients. As part of the arrangement, the terminally ill cancer patients will be taken care of at VHS at a nominal bed charge.

#### **CENTRE FOR EXCELLENCE IN RARE DISORDERS**

CERD proposes for the first time in India a holistic approach to the treatment of children and adults affected with genetic disorders by Multi-Specialty Specialists. Generally, those suffering from genetic disorders face multiple disabilities requiring care from various Specialists. The unit was inaugurated on 28 Feb 2018.

FCRF approached VHS for setting up the above CERD at its premises .The rationale of CERD being housed in a Multi-Specialty hospital like VHS is that it will facilitate health care access more affordable to the affected persons and all the required facilities available under a single roof.

#### **REACH**

VHS has partnered with REACH (Resource Group for Education and Advocacy for Community Health) to enable subsidised treatment for patients with Tuberculosis. As per the engagement, VHS shall provide subsidised consultation for patients referred through REACH and also render investigation and diagnostic services as per the requirements of the patients. VHS started its consultations for patients effective October 2017 and many patients have been benefitted through the programme as all the specialties are available here.

#### Nissan Lodgy

During the year, Nissan Renault Financial Services India Private Limited (NRFSI) as part of their Corporate Social Responsibility, donated to VHS a Renault Lodgy vehicle. NRFSI towards fulfilling its obligation under CSR is desirous of undertaking activities in the areas of the promotion of health care. The Vehicle was very much the need of the hour for the organisation and has helped a great deal for visiting the primary health centres, which are within a radius of about 50 kms. It has become hassle-free for the organisation to perform outreach programmess and medical camps in these rural areas.



#### 6. SERVICES WE OFFER

#### 60 YEARS OF RENDERING HEALTHCARE SERVICES AT AFFORDABLE COST



a) Out – Patient Services: The total number of out-patient consultations during the year 2017-18 is 67164 as against 60102 during the year 2016-17. There has been an increase in the patient walk-ins by 12% when compared to the previous year. Every patient visit made within 7 days from the date of original visit for the same speciality is considered free. During the year under report, such free walk-in patients amount to 20149. VHS charges a nominal fee for its OP

consultation which is Rs. 50 for General Medicine and General Surgery, Rs. 100 for Specialities and Rs. 300 for Super Specialities.

**b) In-patient Services:** The total number of in-patients treated during the year was 5451 and out of the total, 4088 representing 75% of the patients, were from the general ward who enjoy subsidised rates across all the facilities. The department-wise category of patients and the amount of subsidy provided as against A-Ward patients in our hospital can be referred to in the relevant sections.

#### 6.1 Chief Minister's Health Insurance Scheme

VHS Hospital is approved by the Chief Minister's Health Insurance Scheme for Dialysis, General Surgery, Neurosurgery, Urology, Thalasaemia, Orthopaedics and Plastic Surgery. The hospital uses it as an opportunity to join hands with the Government to serve the weaker sections of the society and continues to provide care under the scheme. During the year, routine Health Camps and Mega Camps as part of the Tamil Nadu Chief Minister's Health Insurance Scheme were conducted.

#### 7. DEPARTMENT AND FACILITIES

#### 7.1 Department of General Medicine

#### **Background and Salient features**

The Department of General Medicine in VHS was established by the founder, **Dr. K.S.Sanjivi**, himself. Since the inception of this hospital, the Department of General Medicine has been the cornerstone for all the branching departments and handled steadily by eminent physicians over the years.

A routine day begins with the OP Department starting its work at 8 a.m. strengthened by the visits of senior specialists on fixed days in a week. Casualty Services are available round the clock through an Emergency and trauma care department which was inaugurated during the year. The Day Care Centre provides prompt and brief hospital services such as dehydration correction, nebulisation for acute respiratory distress of the patients etc.

The in-patient wards are adequately cross-ventilated and ward arrangement well spread out in the infrastructure of the hospital layout. The access to any investigatory modality, such as radiology, ultrasonography, etc., is available freely, resulting in fruitful interaction between the departments to the advantage of the patients.

We have backup of teams of specialists in various other allied departments of general medicine and the consultants of the respective departments visit and give their expertise at the patient's bedside. We practise thorough exchange of knowledge to the benefit of the patients by holding review sessions.

The total number of in-patients treated during the year was 1461 out of which 1082 patients constituted the general ward category. The total subsidy provided to the patients in the department during the year was Rs. 32.79 lakhs as against a subsidy of Rs. 27.19 lakh during the year ending 31 March 2017.Out of the above Rs.27.38 lakhs is provided towards the General Ward patients.

#### 7.2 **Department of General Surgery**

#### **Background and Salient features**

This department started functioning as a skeleton unit when VHS was started in 1963. It has now grown into a fully staffed and also a teaching department of the hospital. The following are the activities of the department:

theatres (5 regular and 1 septic OT) are equipped to deal with emergencies / trauma and routine surgical cases.

- Super-specialty services like Urology, Plastic Surgery and Neurosurgery are also carried out in the same OT
- Laparoscopic surgical facilities are also available with experienced surgeons manning them
- There is a Post-operative ward to attend to major cases in the immediate post-operative period and also seriously ill cases, apart from the regular/ICU facilities

#### Academic activities

The Department has been maintaining regular academic training of post-graduate (Diplomate of National Board of Examinations) students every year, apart from surgical training for dental students (BDS) as part of their curriculum, and also gives hands-on training to nursing students of the VHS - M.A. Chidambaram Nursing College located in the campus.

Of the total number of IP cases, the patients admitted under the subsidised ward were 518 (2016-17: 480) and the value of subsidies offered to these patients amounted to Rs. 52.93 lakhs (2016-17: Rs.30.86). # 7.3 Department of Maternity and Child Health The Obstetrics and Gynaecology - MCS Department was started in 1990 with assistance from the Indian Population Project (IPP) V DEPARTMENT OF MATERNAL AND CHILD HEALTH ABHIMANYU BLOCK (2017)

TERNITY AND CHILD HEALTH SERVICES

Apart from the above recently developed facilities, the Department has a cardiotochograph and foetal doppler which has helped in better monitoring of women in labour. Specialised minimally invasive laparoscopic surgeries have been introduced for gynaecological patients on a regular basis. With the help of the Ultrasound Department, procedures such as ultrasound guided aspiration of ovarian cysts, removal of IUCD, etc., are also being done.

This is a baby-friendly initiative hospital, and all mothers are being counselled and encouraged for exclusive breast feeding which is totally successful. Regular post-partum clinics are being conducted and family planning measures are provided according to Government of India guidelines including laproscopic sterilization, MTP facilities are available for patients who opt for it if within the rules.

The OG department is recognised by the National Board of Examinations for PG degree training in Obstetrics and Gynaecology & the pass percentage is maintained at 100%.

#### Facilities available

- Operation theatre with high end equipments exclusive for performing MCS and OBG cases within the same complex.
- Starting of specialised clinics, like PIH clinic and high risk pregnancy clinic
- Basic assisted reproductive clinics with IUI procedures with counselling for infertile couples
- Preparation of special Antenatal Cards to improve care during pregnancy was introduced in 2012. Special counselling for antenatal mothers and their husbands is being done on the importance of regular antenatal checks and nutritional diet, etc. on the penultimate Saturday of every month.

7.3.1**Infertility Clinic:** Infertility Clinic was started during the year 2015-16. Dr. Sathya Balasubramanyam, a honorary consultant, heads the department and is a qualified infertility specialist. Intra-Uterine Insemination (IUI) is done at a very low cost. We hope to establish a full-fledged fertility unit to help childless couples from all the strata of the society.

We receive Grant-in-Aid for running the Family Welfare Centre from the Directorate of Family Welfare and are thankful to the Directorate for continuing to release the grant for meeting the recurring expenditure towards staff salaries, drugs, diet, and the tubectomised mothers.

The total value of subsidised services provided during the year amounted to Rs.48.66 Lakh (2016-17 :37.91 lakh) out of which Rs. 35.72 lakh was towards the services provided to the General Ward Category. 71% of the total IP patient strength constituted General Ward category patients.


#### 7.4 Department of Paediatrics and Neonatology

#### **Background and Salient features**

All deliveries conducted at VHS, both normal and caesarean, are attended by the neonatologists for resuscitation of the babies at birth. The babies admitted in the NICU are both intramural (VHS born) and extramural (referred from outside). Babies born here are regularly followed up in the Paediatric OP and counselling about feeding, immunisation and child rearing is given to them.

Several of the common paediatric emergencies like febrile fits, seizures, dengue shock syndrome, and tablet poisoning are handled in our Paediatric Casualty and admitted as inpatients, if necessary.

#### State-of-the-Art Neonatal Care at VHS



State of the Art Neonatology centre was inaugurated during the year 2016-17 with facilities to provide neonatal care to the new born babies.

7.4.1 Immunisation programme: All children born here are immunised as per schedule, the vaccination being made available at a subsidised cost. The team of paediatricians also conducts training programmes for nurses on neonatal care.

#### 7.5 Department of Cardiology (Institute of Cardiovascular Sciences and Research)

#### **Background and Salient features**

Cardiology Block opened on 24 Sep 2010 (donors Mrs. Jayalakshmi Varadachari and Marudhar Kesari Jain Seva Sangh) **Donors for Equipment:** Chennai Wellington Corporation Foundation, Autotech,Cognizant Foundation and Others

The Department basically provides out-patient services with ECG, Treadmill and Echocardiogram. The beneficiaries are members who belong to the less privileged sections of society. They are mostly workers with monthly incomes less than Rs. 15,000. Apart from the consultations at a concessional rate, they get subsidised rates for investigations, procedures and medicines.

The EECP (Enhanced External Counter pulsation therapy) treatment was inaugurated during September 2012 and has helped patients with advanced heart disease, like intractable chest pain, heart failure, etc., and who do not respond to conventional medicines and cannot be treated with bypass surgery or angioplasty. This treatment lasting 6 weeks has led to significant improvements in patients with these problems.

The Institute of Neurological Sciences (TINS) at VHS was established 52 years ago by the Late Prof. Krishnamoorthy Srinivas, the founder Chairman of TINS.

TINS continues to provide excellent I.P., O.P. and Acute Care for patients, academic courses, and a PhD programme. TINS has expanded into a hub for community-based professional training, academic courses, internship training for post graduate candidates (social work and psychology), PhDprogramme, providing exposure to neuroscience research and expert clinical neurology.

On 17<sup>th</sup> March 2018 Dr.J.Senthil Nathan, MD, DM (Neuro) has been appointed as Head of Clinical Services for TINS-VHS and VHS CARES. He has been instrumental in collaborating with the Department of Neuro Surgery to enhance quality of patient care, academic and research for patients with Neurological disorders.



#### 7.7 Department of Neurosurgery

#### **Background and Salient features**

The Dr.Achanta Lakshmipathi Neurosurgical Centre and Postgraduate Institute of Neurological Surgery at the VHS Hospital and Research Centre, Adyar, has been at the forefront of neurosurgical care, education, innovation and research for the past 40 years (1978-2018).



The institution has been a recognised postgraduate training centre for the National Board of Examinations. Since 1984, there have been 33 postgraduates who have undergone strenuous training of 5 years before writing the National Board examinations. The institution is currently allowed one candidate per year and the course is now for 6 years. The candidates are selected by the National Board on the basis of an all-India examination and counselling done centrally.

#### SIGNIFICANT PAST ACHIEVEMENTS/ MILESTONES

Treating a huge number, of neurosurgical patients, that were managed both conservatively and surgically is the main achievement of this institution. A creation of a distinct Indian school of Neurosurgery has been its hallmark. Multi-author textbooks published by the Department are the main source of educational material for neurosurgery postgraduates.

#### 7.9 Department of Diabetology and TAG-VHS Diabetes Research Centre

#### **Background and Salient features**

**Dr. C. V. Krishnaswami** has headed the VHS Diabetes for over 48 years and has guided and educated many doctors in the field of diabetes.

The **special services** of the Department include:

- Regular out-patient services for all diabetics
- Comprehensive lifetime free medicare for all Juvenile Insulin Dependent Diabetics (IDDM), i.e. children with onset of Type 1 diabetes below 15 years of age
- Diabetes and Pregnancy service
- Full ophthalmic (eye) check-up with documentation and regular follow up in collaboration with the VHS Eye Department
- Diabetic Foot Care clinic pioneering work in limb salvage techniques presented in national and international forums
- Diabetes Renal Care service
- Special Nutrition service
- Psycho-social support and rehabilitation for Insulin Dependent Diabetics

The **Nutrition Department** provides a dedicated diet counselling service, especially for diabetics with kidney complications (diabetic nephropathy and early renal failure cases) with specific goals of holding / reversing the condition and postponing / preventing renal dialysis – this effort has achieved very significant success.

Another special feature is the **Diabetes Pregnancy unit** which functions to improve patient care, maintenance of the registry for gestational diabetes, and cater to the special needs of high-risk pregnancies associated with diabetes.

The Department is also functioning with a **Diabetes Neuro clinic** rendering services for people with diabetic neuropathies and a variety of other associated neurological problems.

A unique feature of the VHS Diabetes Department is its serving the Juvenile Insulin Dependent Diabetes patients with *comprehensive lifetime free medicare* which offers free medicines, insulin, syringes, annual blood tests, chest x-rays, ECG, ultrasonography, fundus fluorescein angiograms, laser photocoagulation therapy (when needed), neurological investigations, investigations and treatment of diabetic foot problems, and treatment of inter-current problems in Insulin Dependent Diabetes Mellitus. In addition, regular treatment of DKA, hypoglycaemia and other metabolic problems requiring hospitalisation are done free of cost for all IDDM cases. These services with constant improvements have been offered to the economically/socially backward classes for the past four decades.

The *Goals* of the Department are:

- To improve and monitor the natural history of (Type 1) Juvenile insulin dependent diabetes in South India, on a long-term basis.
- To look after Type 2 diabetics long-term with use of minimum/appropriate/and user-friendly drug therapies, diet and lifestyle advice, and keep close electronic medical records of their health conditions and suggest appropriate non-invasive and non-chemical-based interventions for the various co-morbid conditions so that the least amount of end-organ/micro-vascular complications occurs. We have succeeded to a significant degree in this endeavour and have maintained full computer-based medical data of our patients' conditions over the past 48 years. **Statistics**



#### Services offered

#### 1.Medical treatment -

- Medical care to deal with withdrawal symptoms, and
- Co-existing medical/psychiatric breakdown or suicidal attempts due to addiction.

Both alcoholics and drug addicts are admitted in the ward for a minimum period of 24 days. Detoxification is done during the 1<sup>st</sup> week and, in the 2<sup>nd</sup> week of admission, cardiac and liver status is also assessed.

If all the parameters are normal, the patients are started on Disulfiram/Acamprol therapy. Individual counselling, Family counselling and Group therapy are provided for the patients. Simultaneously, all the patients are subjected to a battery of psychological assessments like MMPI (Minnesota Multiphasic Personality Inventory), GRS (Rating scale for Depression), SCL (Symptom Check List) and IQ. Inter-medical facilities are available for the patients admitted in the de-addiction ward. If a patient admitted is found to have ailments like cardiac, TB, skin, eye, ENT, ortho or surgical problems, all the problems are handled simultaneously.

- 2. <u>Psychological therapy:</u> With the focus on abstinence with improvement in the quality of life, it covers Assessment, Counselling, Group therapy, Re-educative lectures and Family therapy
- 3. <u>Supportive therapies:</u> Life skills training on strengthening self esteem, stress management, assertiveness, decision making, problem solving skills, and Yoga / relaxation techniques are given.

There is also a relapse prevention programme – to recognise high risk situations and emotional triggers that lead to relapse and to learn coping methods.

The ward has indoor recreational facilities like carrom board, chess, badminton, and TV. During their stay, the patients engage themselves in gardening and other recreational activities. The Annual Day is celebrated every year and small mementoes given to recovered patients who continue to be sober. It is very heartening to note that the rehabilitated patients themselves motivate others and bring them for treatment in the Centre.

They continue to work as volunteers and help in the follow up of patients. It is noteworthy that some of the patients have also contributed financially for the upkeep of the Centre.

#### Follow up services

Clients and their family members are counselled on future follow up and regular intake of medicines. If the clients do not come for follow up, they are contacted by telephone, letter or home visit.

#### **Outreach programmes**

The Department has been regularly conducting awareness programmes on substance abuse and its ill effects through lectures, interaction, street plays, etc. in schools, polytechnics and colleges, self-help group members (men and women), and in slum areas visit the Government Vigilance Home, Chennai, for counselling the inmates once a month.

#### 7.11 Department of Orthopaedics

The Department of Orthopaedics is one of the super specialities which has been in existence since the beginning and has progressed to a great extent over the years. The various treatments provided under the department are:

- 1. All complicated trauma cases
- 2. Arthroscopy
- 3. Joint replacements
- 4. Paediatric Orthopaedics, with deformity correction
- 5. Specialised trauma care for accidents and emergency

The number of IP cases in the Department has significantly improved during the year as compared to the previous year. The General Ward patients constitute around 70% of the overall patient strength. Out of the total in-patients, the amount of subsidies provided in the Department was Rs.23.32 Lakhs (P.Y :16.62 lakh), primarily towards 133 (P.Y: 128) patients belonging to the General Ward and C Ward categories.

#### 7.12 Department of ENT

The Department has a separate operation theatre with an operating microscope and audiogram, with special facilities for surgery on deafness. It is equipped with start of the art equipment and with increasing response from the public; it is in the expansion mode for conducting additional procedures at affordable cost.

Out of the above 75 in-patients, subsidies have been provided for a total value of Rs.1.76 lakh. The Department is run by a doctor deputed from SRMC, and is showing significant improvement in terms of quality and affordable care.

The Department is fully equipped with necessary equipment. Under electrotherapy, there is shortwave diathermy, ultrasound, interferential therapy, wax therapy, electronic traction and a continuous passive machine.

Exercise therapy equipment include a treadmill, parallel bars, mariner's wheel, multipurpose pulley, quadriceps table, staircase, elbow exerciser, wrist circumduction, tilting table, rehabilitation unit, C.P chair, and re-education board.

#### 7.14 Department of Ophthalmology

Set up by Dr. S.S.Badrinath

Services available at present:

- Humphrey field analyser, FDT, Forus Fundus Camera, A scan, etc., for covering a wide variety of problems including diabetic eye disease and neuro-ophthalmology
- Retinal Surgeries

The Department has a separate operation theatre with an operating microscope and facilities like photocoagulator, Fundus Camera, and fluorescent angiogram equipment

The Department has also collaborated with the Mini Health Centres operated in collaboration with the VHS-MAC Institute of Community Health. This did make a noticeable impact on the curable blind people of the community and set a benchmark for other organisations to follow. WHO launched cataract surgery with IOL implantation much later, which has since been accepted as the method of choice by the Central and State Government. This programme has been the flagship programme done in association with the Sathya Sai Samithi for more than 15 years and is still an ongoing programme.

Apart from the curative side, the Department has, since 2011, launched a major initiative to prevent blindness resulting from glaucoma and diabetic retinopathy. VHS has launched the VHS-MAC **Choodamani Blindness Prevention Project** at Sholinganallur in 2012.So far, about 500 people in the community have been screened and appropriate measures instituted.

The department is supported by various philanthropists for funding cataract surgeries and vitro retinal surgeries for the poor patients. During the year, Rotary club of Madras, South Trust had funded 10 retinal surgeries.67 patients were benefitted through OCT investigations using the endowment funds of The Hindu Group and 6 patients were benefitted through B scan using the endowment funds of Pavithra Kotha Vijayakumar Memorial fund.

#### 7.15 Nephrology Department and Dr.R.Babu Kulasekar Dialysis Centre

#### **Background and salient features**

The Department is run by an experienced Nephrologist under whose guidance haemodialysis is conducted.

The air-conditioned Dialysis Centre has four haemodialysis machines, with central oxygen and suction facilities and is operational throughout the year. Along with the Nephrology Consultant, two dialysis technicians, and a staff nurse attend the cases. The Centre is approved under the Chief Minister's Insurance Scheme.

The Department of Oncology was inaugurated in July 2014 and is a fully equipped centre of medical oncology with nine beds, air-conditioned, and Central Oxygen supply. The Department continues to provide Chemotherapy with all required infrastructure and handles patients as day care patients, with trained staff. Patients, for whom monitoring is required, stay overnight in the centre and, if need be, are transferred to the Intensive Care Unit at VHS. Chemotherapy is provided at a subsidised rate at the Department. The drugs used for Chemotheraphy are sold at 40% less than the MRP.

#### 7.18 VHS-YRG Care Medical Centre and Infectious Diseases Department

#### Background and salient features

The VHS-YRG Care Medical Centre, set up in VHS with the support of the Y.R. Gaitonde Centre for AIDS Research and Education, has a 24-bed ward and a day care centre that treats AIDS patients. Other than Government Hospitals, VHS is the one of the very few private hospitals to take care of HIV / AIDS patients.

The Operation Theatre and Labour Ward Block handles cases with HIV. It has out-patient cubicles and 4 special air-conditioned ward rooms with attached bath.

To offer the patients added services, the VHS-YRG Care Infectious Diseases Laboratory focuses on newer diagnostic methods and research on HIV / AIDS and other opportunistic infections. It has been recognised by the National Accreditation Board for Testing and Calibration Laboratories (NABL) and the Department of Scientific and Industrial Research (DSIR).

# 7.20 ROTARY CENTRAL-TTK-VHS BLOOD BANK

# Background and salient features

The VHS Blood Bank started functioning from 1962 under the guidance of Dr. K.S. Ranganathan, former adviser on blood transfusion to the Director General of Health Services, Government of India. The blood bank, from the very beginning, has encouraged voluntary blood donation. **Dr.J.Balasubramaniam**, who joined the blood bank as the Medical Officer in August 1964, is currently its Director.

In 1997, the Rotary Club of Central Madras and TTK ventured into the field of blood banking and helped to provide the VHS Blood Bank with modern blood bank equipment and trained personnel. The Rotary Club of Madras also donated the present building to house all the advanced equipment.

The Blood Bank is licensed by the Drug Controller and all blood samples are screened for HIV, hepatitis, VDRL for AIDS, and Jaundice and STD respectively, before they are transfused. The services of the Blood Bank are available round the clock. It is staffed by qualified and trained medical officers, staff nurses, technicians and blood bank workers. It has a well-equipped air conditioned van to go for blood donation camps and for transportation of blood and blood units collected for immediate processing.

The intensive drive for building up the stock of blood continues. We are thankful to the donors and organisers of the various institutions who participated in the Blood Collection camps. A total of 167 camps were conducted and 14,846 units of blood collected during the year under report.

All blood and blood components are given free of cost to all the patients with haemophilia and thalassaemia irrespective of their income groups. The value of such free blood issued during the year 2017-18 amounted to Rs.49.38 lakh (2016-17 Rs. 37.39 lakh). Also blood is issued at 50% discount to the General Ward patients.

### Haemophilia Centre

As part of the programme, the Blood Bank gives 24-hour comprehensive care to haemophiliac patients along with free blood and blood components including cryoprecipitate. We are thankful to the Haemophilia Society – Madras Chapter for organising this free supply for deserving patients and for taking full care of them.

#### 7.21ROTARY CLUB OF MADRAS – VHS SENIOR CITIZEN CENTRE

#### **Background and salient features**

The Centre was inaugurated on 19 July 2003 by Mr. M.V. Subbiah, Executive Chairman, EID Parry (I) Ltd in the presence of the then President of Rotary Club of Madras, Mr. D Sudhakara Reddy, Dr. M.S. Swaminathan and Mr. S. Venkitaramanan

The main objective is to provide  $24 \times 7$  medical care for old aged people and to enable them to maintain a healthy lifestyle.

#### **Facilities available**

- There are 11 single rooms,4 smaller rooms and 20 double-occupancy rooms, with attached bathroom. A nominal amount towards rent and food expenses is collected every month and basic necessities are met with.
- A common room with dailies and magazines is available.

- *Bhajan*sessions are conducted periodically.
- A doctor visits the residents once in a week as part of the services provided.

# **INSTITUTE OF COMMUNITY HEALTH**

# Department of Community Health The Voluntary Health Services

The VHS Department of Community Health (Institute of Community Health) comprises 10 Mini Health Centres(MHCs) located along the OMR and ECR and conduct regular activities such as

- Clinical Services and Community Health Outreach such as daily house visits, camps, school health, community group interactions such as nutrition demonstrations etc
- Training is conducted for medical, nursing and paramedical courses as per the University syllabus

# Outreach

Clinical and community health outreach is done through 10 Mini Health Centres which are located in southern periphery of Chennai city mostly located on the ECR and OMR arterial roads. The catchment area of the Mini Health Centres covers a population of nearly one lakh for clinical services and approximately half are covered with regular outreach such as daily house visits. The Community Health outreach services offered under the eight core activities such as Water, Sanitation, Women health, Child health, Nutrition, Communicable diseases, Non-Communicable diseases and Clinical practice. Other activities like Nutrition Demonstration, Group health Education, Provision of Weaning Mix and School health visit are done on a regular basis.

# **Field work**

The Multipurpose health workers make daily home visit as per the Fixed Tour Programme(FTP) in order to cover the entire population for every two months under each Mini Health Centre. This outreach provides basic clinical care, preventive and promotive services by medical officers along with multipurpose health workers and trainees posted at the Dept of Community Health for postings. Cases that require specialized care are referred to the main hospital at Adyar.

# Training

Training is undertaken at the Institute of Community Health at Thuraipakkam and practical postings at various mini health Centres. Trainees include CRRI posting, MD Community Medicine, M.Sc Nursing, B.Sc Nursing, Diploma in Nursing, Post Basic B.Sc Nursing and other streams such as nutrition, pharmacy etc.

Non-formal training is based on request from various organisations such as Rotary Clubs, NGOs etc and is tailor made to requirements.

For the reporting period a total of 333 students were trained in 84 batches

# Other Activities Camps sponsored by Oriental Insurance Introduction

Free medical camps are periodically conducted by VHS Mini Health Centres to reach health care services to poor and underprivileged communities living in slums, resettlement tenements and along canal banks. Medical camps fulfil unmet health care needs of people having poor health seeking behaviours. Free medical camps organized by VHS extend quality medical care services, free medicines and health education to the needy and underserved populations living in peripheral areas surrounding Chennai.



# **Medical Camps**

VHS conducted three free medical camps for the benefit of communities living in and around Neelangarai (20<sup>th</sup> August 2017), Thuraipakkam (3<sup>rd</sup> September 2017) and Sithalapakkam (10<sup>th</sup> September 2017).

Each of the three free medical camps were sponsored by The Oriental Insurance Company Limited (a Government of India Undertaking) under its Corporate Social Responsibility (CSR) initiatives.

The community response was overwhelming with a continuous stream of people throughout the day, including women, men, infants, children, adolescents, elderly, differently abled, infirm residents and people who are unable to afford quality medical care.

A total of 1,306 people (Neelangarai - 368, Thuraipakkam - 277 and Sithalapakkam - 661) in need of medical care benefitted from the camp.

Beneficiaries included working women and men, daily wage earners, domestic workers, casual labourers, construction workers, fisher folk, factory workers, security men, auto rickshaw drivers, loadmen, shop assistants and staff from

housekeeping services.

Residents of resettlement colonies, people living along the canal banks and workers from the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for poor households also availed the free medical services.

#### **Health Care Providers**

Free medical care services and health education were offered by a panel comprising VHS Medical Officer, Attending Doctors, Public Health Nurse, Optometrist, Staff Nurses (Ophthalmology) and Multi-Purpose Health Workers. Urban Health Nurses from the Corporation of Chennai also provided assistance during the medical camp.

#### **Health Education**

The free services provided included monitoring of vital signs (height, weight, pulse, temperature, and respiratory rate), checking of blood pressure, and blood sugar test for detecting diabetes, eye examination, clinical examination, and diagnosis of common ailments, distribution of free medicines, health education and nutrition demonstration.

The team of Attending Doctors, Nurses and Health Workers were supervised and managed by Dr. A. Kalaiselvan, Medical Officer, Department of Community Health, and VHS.

Some of the frequently reported symptoms during the camp were common cold, fever, cough, wheezing, body pain, joint pain, knee pain, muscle pain, headache, eye problem, white discharge, anaemia, arthritis, allergy, itching, skin infections, gastritis, hypertension, diabetes and vitamin deficiencies.





Doctors attending on beneficiaries listened to the complaints and symptoms, undertook clinical examination, diagnosed the cause, gave advice and prescribed medicines to treat the illnesses.

Beneficiaries with risk factors for developing diabetes, such as age (over 40 years), family history, overweight, obesity, lack of physical activity and high blood pressure, were screened. Upon recommendation by the Medical Officer and attending Doctors, a total of 274 beneficiaries were screened for diabetes.

Eye examinations were conducted and cases were referred to VHS hospital for follow-up care. Refractive errors, cataract, retinal problem, itching, eye pain and headache were some of the eye related conditions reported during the camp.

Free medicines were dispensed to beneficiaries in branded medicine covers. The most

commonly prescribed medicines during the camp included antibiotic, analgesic, broncho dilator/asthmatic, gastric, anti-emetic, anti-allergic, anti-spasmodic, anti-diarrheal, anti-helminthic, anti-amoebic, ointment and vitamin supplement.

# **Health Education**

VHS Public Health Nurse and Multi-Purpose Health Workers managed a health education and nutrition demonstration desk during the medical camps. The team carried out health awareness sessions and disseminated health promotion messages among beneficiaries.

Key messages on disease prevention and healthy living were shared with beneficiaries through one-on-one interactions, group discussions and demonstrations. Health Workers stressed the importance of eating a nutritious diet, explained safe hand washing practices and urged beneficiaries to adopt healthy living habits.

During interactive health education sessions facilitated by Public Health Nurse and Health Workers, beneficiaries learned about preventing common diseases, adopting healthy living habits, keeping surroundings clean, maintaining personal hygiene and ensuring safe storage of drinking water.

Using pictorial flip books, posters, flash cards and interactive dialogues, Health Workers shared key messages about air and water borne diseases, malaria, dengue and chikungunya.

Health Workers conducted nutrition demonstrations showing beneficiaries how to prepare simple, low cost and nutritious recipes, such as green gram vegetable salad, vegetable sandwich and sweet red Aval (flattened red rice) salad. Health Workers stressed that these recipes could be easily made at home using locally available ingredients.Following the demonstration, beneficiaries were offered a sample of the prepared item for tasting. Beneficiaries realized that the preparations were not only tasty and affordable, but also contained high nutritive value.

Adolescent girls were sensitized on anaemia caused by iron deficiency and shown the importance of eating a balanced and nutritious diet. Health Workers spoke about the steps people should take to prevent diseases and live a healthy life.

#### **Follow-up Care**

Beneficiaries requiring specialized medical care were referred to VHS Hospital for further investigation and treatment.

Beneficiaries were also advised to visit the Mini Health Centre for follow-up consultations and medicines.

During scheduled house visits, Health Workers will meet beneficiaries to monitor their health condition and provide follow-up care.

centre field supervisor, school teachers, anganwadi worker and private company supervisors.

Publicity was done through house-to-house visits by Health Workers, leaflet distribution, poster display at important congregation points and public announcements via mike fitted on autorickshaw.

#### **Record Management**

Beneficiaries were registered for the medical camp by Health Workers using an Out Patient (O.P.) register, listing their name, age, gender, phone number and address. Following registration, each beneficiary was handed out an

O.P. sheet for availing services.

The O.P. sheet recorded vital signs (height, weight, temperature, blood pressure, pulse and respiratory rate) checked by Health Workers as well as complaint, clinical examination, diagnosis and drugs prescribed by the doctor.

After seeing the doctor, the beneficiary handed over the O.P. sheet to the drug dispensing unit for collecting prescribed medicines.

Medicines dispensed to beneficiaries were recorded in the Drug and Stock Register maintained by Health Workers.

#### **Company Visibility**

The visibility of The Oriental Insurance Company Limited was ensured through activities carried out before and during the camp. Two banners measuring 6 feet x 4 feet were displayed at the entrance and inside the venue ahead of the camp as well as on camp day, promoting the Company brand.

The visibility and image of the Company was further enhanced through the use of branded medicine covers for distributing free medicines to beneficiaries.

#### **Voices of Beneficiaries**

The community responded positively to the medical camps by turning out in significant numbers to avail free health care services and medicines. Beneficiaries expressed their gratitude for the free examinations, tests, consultations, health education, nutrition demonstrations and medicines. The thoughts and feelings shared by a select few beneficiaries are noted below.

# Neelangarai

"I am from Kerala and was passing by when I noticed the banner outside the Mini Health Centre. Normally I have doubts about free medical camps and hesitate going to such camps. However, after attending this free camp and consulting doctors and Health Workers from VHS, my opinion has changed. I am impressed to see and experience the quality health care you are giving. Your service is excellent. VHS is helping the poor people living in this community." Male, 60 years.

"I came with my husband. We do not have anyone to take care of us. I am satisfied with the medical camp and the medicines provided free of cost." Female, 70 years.

"I am from Kolkata and work at a nearby biriyani outlet. I live and sleep inside the shop. I am suffering for several years from frequent cold and weakness. I have seen many doctors, but only get temporary relief when I take medicines. I have come to this camp seeking your help in treating my health problem." Male migrant worker, 16 years.

"Neelangarai Mini Health Centre has been my saviour. Without services of this centre and Health Workers, I will not be alive today. Thank you for the camp and free medicines." Male, 65 years.

"I have come here with my son. We are very happy with the free health care services you are giving." Female, 60 years.

#### Thuraipakkam

"Our entire family was able to benefit from this free medical camp" stated an elderly woman and her daughter who came with three children suffering from cold, cough, fever and pain.

"We learned how to easily and quickly prepare healthy, tasty and nutritious food and we are going to make them at home" said two school going sisters.

"Doctors and Health Workers were helpful, listened to our complaints, understood our health condition and gave us free medicines, thank you" expressed another beneficiary.

"All of us are having fever and our son is also sick. By coming to this camp, we were able to see a doctor and get free medicines" said a young woman.

"It feels like you did this camp just for poor people like us, thank you" stated a family of husband, wife and two children. They also expressed satisfaction with the arrangements and thanked VHS and the sponsor.

#### Sithalapakkam

"We came as a family for undergoing check-ups and to see a doctor. My daughter is having cold, chest congestion, fever and breathing problem and we needed medicines. We are satisfied with the services and medicines received at the camp. Thank you for organizing this camp for us." A 55-year-old woman engaged in household work.

"I am suffering from cold, cough and drowsiness. The doctor understood my condition, made me comfortable and took good care of me. Thank you for the free medicines." A 75-year-old man who used to pull a rickshaw to earn a living.

"Today, we were taught how to make a healthy and tasty salad at low cost. Thank you for explaining in an easy to understand language and showing us step-by-step how to make nutritious food at home." A group of school going adolescent girls.

"The Health Workers told us about keeping our homes and surroundings clean and avoid water stagnation so that we can prevent the spread of mosquitos and safeguard ourselves from dengue and malaria. Thank you." A 35-year-old mother with two sons aged 7 and 10 years.

"I work at the local factory filling plastic pouches with oil. Due to the nature of my repetitive work I am constantly suffering from elbow pain. I came here to consult the doctor, get medicines and relieve my pain so that I can continue working and earn a livelihood for my family. This free camp is very helpful for us." A 50-year-old woman working in an oil factory.

"Because of this free camp, we were able to check our height, weight, blood pressure, blood sugar and eyes. Thank you for providing us this free service. The services offered were very good and helpful. We were well taken care of by the Doctors, Nurses and Health Workers." - An extended family of mother, father, son, sister and nephew.

#### CM Insurance Scheme Camp

A free medical camp under the CM Insurance Scheme was conducted at Kanathur on the occasion of the former Chief Minister's birthday on 27<sup>th</sup> Feb 2018 and a total of 222 patients were seen.

## Sathya Sai Monthly Camps at Siradhavoor

Monthly camps are conducted by the volunteers of Sathya Sai and the Dept of Ophthalmology VHS, for the period of reporting a total of 11 camps were conducted with a total of 2462 patients seen.

## Voluntary Health Services -Multi-Country South Asia – Project DIVA

# Voluntary Health Services -Multi-Country South Asia – Project DIVA supported by the GFATM Round 9 Programme

#### **Background:**

VHS under the Global Fund Round 9 programme is implementing the Multi-County South Asia (MSA) DIVA project in India (except North East) with the support of Save the Children International (SCI), Nepal. The project under the guidance of National AIDS Control Organisation (NACO) and in partnership with respective State AIDS Control Societies (SACS) aims to reduce the impact of HIV on Transgender (TG) / Hijra (H) population.

#### Achievements:

- 1. The initiatives taken by VHS-MSA DIVA Project towards the marginalized TG/H people has paved in the following outcomes, many of them being the first of its kind in the State:
  - Andhra Pradesh
    - 1. Honorable Chief Minister of Andhra Pradesh has announced State Welfare policy for the Transgender people
  - o Bihar
    - 1. Transgender Welfare Board has been formed
    - 2. The Government of Bihar has announced 1% reservation in employment for the Transgender people
    - 3. Bihar State AIDS Control Society has announced to recruit Transgender people as Care Counselors at the ART centres
  - o Odisha
    - 1. Passport has been issued with gender category that includes Transgender person
    - 2. State Transgender policy has been framed
    - 3. Government has sanctioned loan for livelihood of Transgender people
    - 4. Gender neutral toilets has been built for Transgender people
  - o Chhattisgarh
    - 1. Transgender person has been recruited at the State Police Force
  - o Gujarat
    - 1. A Transgender Welfare Committee has been formed



- o Kerala
  - 1. The first cooperative society for Transgender people has been formed by the Government of Kerala.
- o Maharashtra
  - 1. Transgender persons have been recruited at the District legal aid clinic as para-legal volunteer, as Judge at Lok Adalat and has been selected as Village Sarpanch.
- o Pondicherry
  - 1. During the Transgender people day, an interaction between the Transgender communities and Pondicherry HR Circle was held which paved employment opportunities for TG people.
- o Rajasthan
  - 1. Transgender has been recruited as Police official in the State
- o Tamil Nadu
  - 1. Transgender persons have been employed in the State Government as Police official, Lab technician, Physiotherapist, Siddha Doctor.
  - 2. Many transgender persons have been employed in the private sectors.
  - 3. Government has announced seed funding support for the Transgender people.
- o West Bengal
  - 1. An educational institution has built separate toilet for the Transgender students.
- 2. TG communities and VHS-MSA DIVA Project officials have attended the following National / International conferences:
  - o 7<sup>th</sup> International Lesbian, Gay, Bisexual, Trans and Intersex Association (ILGA) Asia regional Conference at Phnom Penh, Cambodia: Participated in the panel discussion on "Gender based violence in humanitarian settings". Shri Sarada Prasad Panda, Secretary, State Urban Development Authority, Government of Odisha was also sponsored for the conference and he spoke on the topic "From Margins to mainstream: LGBT inclusion in national policy and practice".
  - Rights, Resilience and Resource: Asia Pacific Summit at Bangkok, Thailand: Participated in the discussion on the strategies to reach the UNAIDS goal of 90-90-90.
  - AIDSCON7 Conference held at Chandigarh: Disseminated the "Findings of the Trans Stigma index study piloted in two sites". A poster presentation by VHS-MSA DIVA Project on "Active involvement of media in projecting positive stories of Hijra / Transgender people" bagged the third prize.
- 3. Preliminary discussion held towards the National consultation meeting to develop an advocacy road-map for the Transgender people in the country was held.
- 4. Dr.Bhawani Singh Khuswaha, Deputy Director (TI), National AIDS Control Organisation (NACO), Ministry of Health & Family Welfare, Government of India reviewed the VHS-MSA DIVA Project activities and appreciated the efforts taken by the project towards the welfare of Transgender people in the country.

Smt.Anupriya Patel, Honorable Minister for Health and Family Welfare, Government of India visited the stall acknowledged the efforts taken by the project.
- 7. VHS commemorated World AIDS Day on 1<sup>st</sup> December 2017 involving around 100 nursing studentsfrom M.A.Chidambaram College of Nursing. An oath on accepting PLHIV was taken by the participants.
- 8. The project held a community consultation to discuss on the scope of current Transgender (Rights of Protection) Bill 2016. Representatives from UNAIDS, UNDP and Alliance participated in the meeting.
- 9. Various state / regional level media sensitization training programmes were conducted across the country and many positive stories are being published in the media about TG/H people.
- 10. Five CBOs has been supported under the CSS: Seed advocacy grant and four CBOs have been supported for piloting innovations to reach the unreached TG/H people in different states.

# Technical Assistance to National AIDS Control Programme-Phase IV (TA to NACP-IV) supported by Centers for Disease Control and Prevention (CDC)

The Voluntary Health Services - Centers for Disease Control and Prevention, (VHS-CDC)Project, "TA to NACP-IV', is providing technical support to the National AIDS Control Organization (NACO) in carrying out national level reviews and policy revisions on prevention, care & treatment and strategic information programmes. In line with the revised PEPFAR strategy, apart from the national level activities, the project is now pivoting its efforts in the high burden cluster districts of Andhra Pradesh (AP) and Maharashtra (MH).

VHS-CDC project has undertaken strategic efforts and carried out series of innovative activities in coordination with various stakeholders. Some of the key highlights of the activities undertaken by the project will include:

#### Achievements: April 2017 – March 2018:

# TA to NACO:

- Strategic Information Management Unit (SIMU), Basic Services and Care & Treatment programme of NACO: VHS-CDC project supports positions of technical consultants in NACO as part of its strategic support to NACO.
- Extended **Technical Assistance (TA) to NACO** in developing plans and systems for conducting Joint Implementation Review meeting for NACP IV by involving key stakeholders including donors in selected states.
- TA to organizing National Workshop for developing Risk Assessment Tool: VHS-CDC project has developed risk assessment tool for using ICTCs. The same was presented at the national workshop organized by NACO in collaboration with VHS-CDC project. A sub-committee was constituted for reviewing and finalizing the same.
- Provided Technical assistance to NACO for planning and managing Joint Implementation Review Mission (JIRM) by engaging consultants for undertakingsecondary review, developed ToRs, developed progress report and presentations for JIRM for the period of April to September 2017.
- NACO official visit to VHS-CDC project: Dr. Kuldeep Singh Sachdeva, Deputy Director General (DDG), Basic Service Division, STI & Research, NACO along with Ms. Vinita Verma, Programme Officer, Evaluation & Operational Research, NACO visited the VHS Project Management Unit on 23<sup>rd</sup> January 2018. In this meeting, VHS-CDC project has shared the project experiences, researches undertaken and scope for conduct of research.
- Enhanced the **capacity of District AIDS Prevention and Control Unit (DAPCU) through DNRT**by supporting Regional Coordinators, undertaking mentoring visits to DAPCUs, monitoring and developing score card by analyzing core indicators. Also, contributed in developing DAPCU blog and disseminating DAPCU best practices and experiences through NACO website.VHS-CDC supported the Regional Coordinator and M & E officer has undertaken field visits to DAPCUs and provided onsite mentoring, participated in the state and regional level DAPCU review meetings.

#### PALS (PLHIV-ART Linkage System):

- Developed PALS, a web based online individual tracking system to improve tracking of clients across the prevention-to-care continuum cascade. VHS-CDC project has developed module for uploading data in offline.
- VHS-CDC project in collaboration with APSACS, MSACS and MDACS, has conducted the training program on PALS for ICTC counselors, data managers and DAPCU personnel.
- C delegates inaugurating the PALS training
- VHS-CDC project in coordination with NACO is in the process of documenting the experiences of PALS in the form of process documentation supported with best practices, abstracts and case studies.

VHS-CDC project is providing strategic technical assistance in piloting innovations in the cluster districts of Andhra Pradesh and Maharashtra on the following key areas:

- 1. Risk Assessment Tool

- 4. Strategic Information support (PALS)

VHS-CDC project is working closely with MSACS, MDACS and APSACS and other key stakeholders in piloting the above innovations. As a part of it, appointed cluster team including outreach workers, conducted training programs for ICTC Counsellors, ART staff, DATA managers and DAPCU personnel on ICTC-ART linkage system.

The project personnel both at project office and cluster level team are coordinating with respective SACS, undertaking mentoring visits, participating in the review meetings and providing strategic support

# Training programs conducted at Clusters:

# Technical assistance to NationalSTI/AIDS Control Program in Sri Lanka:

PEPFAR/INDIA has proposed to facilitate bidirectional knowledge transfer on HIV/AIDS between India and Sri Lanka. As a part of this, CDC in partnership with VHS-CDC project is in the process of providing technical assistance to NSACP on strategic information focusing on the following four areas:

- 1. Enhance Strategic Information Management (SIM) Unit capacity to utilize electronic and manual program data for decision making
- 2. Improve capacity of SIM Unit to carryout management, analysis, documentation, and dissemination of summary program data reports
- 3. Improve capacity of SIM Unit to conduct and disseminate results of operational research
- 4. Consultation with stakeholders on monitoring and documentation of accomplishments and sustainability plans

As a part of it, the project has facilitated exploratory visits, meeting with key stakeholders, undertaken field visits to facilities, conducted consultative meetings, etc. Through a process, the project is in the process of providing TA on SI in coordination with SIMU unit of NSACP. The key activities are: signing of Letter of Intent (LoI) between CDC and Ministry of Health (MoH), Govt., of Sri Lanka during Feb'18. VHS has facilitated the entire process of coordinating with the Govt. of Sri Lanka in facilitating formal signing of LoI.

NSACP and shared the same with key stakeholders. VHS-CDC project is also in the process of supporting for developing dashboard indicators. In line with this, developed Comprehensive Dashboard Indicators on STI/HIV/AIDS for TA to NSACP, Sri Lanka and shared.

The project shared the India best practices on Strategic Information and shared the information on SI system in HIV/AIDS program in India, PLHIV-ART Linkage System (PALS) along with the process, reporting units, indicators, special features, use of data for program management and other highlights and also shared the information on IMS and plans on integration of PALS, IMS during Nov'17. This experience sharing has enabled the SIMU team, NSACP for planning in developing the EIMS and integrating the value addition in the development of EIMS.

VHS-CDC is in the process of providing technical assistance on enhancing website, updating M&E plan to align with 2018-22 national strategic plan, providing TA on Electronic Information Management System

(EIMS), TA for developing analytical report on SI, improve capacity of SIMU unit to conduct and disseminate results of operational researches, etc.Senior Technical Advisor has undertaken visits and coordinating with NSACP in the process of planning and coordination.

# 8. RESEARCH ACTIVITIES


#### 8.1 Department of Clinical Research

The Department of Clinical Research was started in December 2014. The scope of the department is to conduct high quality research in translation medicine with the aim to:

- > Improve our understanding of the pathogenesis of various diseases.
- > Test and develop newer treatment modalities.
- > Improve patient handling and management.

#### Achievements:


- Renewal of the institute's recognition as a Scientific and Industrial Research Organization (SIRO) from the Department of Scientific and Industrial Research (DSIR) upto the year 2020.
- Scientific Advisory Committee (SAC) has been reconstituted in order to bring in technical expertise in the various medical fields.
- VHS Laboratory Services operating under the umbrella of the Department of Clinical Research has provided diagnostic services to 21,065 patients during the year under report for whom 2,87,784 tests have been performed. Out of the total collection Rs. 7.72 lakhs has been given as discount. Our rates are closer to CGHS rates and the discount has been calculated from the CGHS rates. The increase in the number of patients and the collection amount in the laboratory compared to the previous year are shown in Figs. 1 and 2.



# **Ongoing projects:**

# > Evaluation of antibacterial, antiviral and immunomodulatory properties of plant extracts traditionally used in Siddha medicine to treat lower respiratory tract infections (LRTI).

This is an ongoing project funded by the Department of Science & Technology, Government of India. In the past year, this study completed the evaluation of the antibacterial, antifungal and antiviral activities in 11 traditional herbal extracts. Of the 11 plants tested anti-influenza viral activity was exhibited by 4 plants (Fig. 3). None of the plants exhibited antifungal activity or inhibitory activity against any of the three Gram negative bacilli tested. The three Gram positive cocci tested were inhibited by the 11 plants to some extent (Fig. 4). The anti-microbial activity is better when the numbers are lower.



## New projects:

▶ Role of inflammatory mediators in the clinical outcome of viral warts – a pilot study.

This is a pilot study designed to generate preliminary data on the role of tumour necrosis factor-alpha (TNF- $\alpha$ ) and interferon-gamma (IFN- $\gamma$ ) in the clinical outcome of viral warts in patients who will be treated with intralesional injections of the MMR vaccine. Though the intralesional injections of the cheaper vaccines are routinely followed in developing countries, their mechanism of action is poorly understood. This study will provide insights into the mechanism.

Multi-drug resistance (MDR) among clinical isolates in a multi-speciality hospital - a retrospective study.

This is a retrospective study proposal to analyse the microbiological data of the clinical samples submitted to the VHS Laboratory from May 2016 to July 2017. The aim of the study is to delineate the multi-drug resistance (MDR) pattern among bacteria isolated from clinical specimens in a multi-specialty hospital. The significance of the study is to throw light on to the emerging microbes within the hospital environment, which would facilitate the hospital's Infection Control Committee to take necessary actions especially regarding the antibiotic policy.

Role of inflammasomes in Multi-Drug Resistant (MDR) bacterial infections.

A pilot study on the role of inflammasomes in multi-drug resistant (MDR) bacterial infection was proposed to generate preliminary data on the levels of innate immunity cytokine, IL-l beta. The data generated will be utilized in grant proposals that will be sent to funding agencies.

# 8.5 Dr. A. Lakshmipathi Research Centre for Ayurveda (CCRAS)

Dr.AchantaLakshmipathi Research Centre for Ayurveda started functioning as a grant-in-aid unit from 1st February, 1965 under the auspices of the Central Council for Ayurvedic Research of the Ministry of Ayush, Govt. of India. According to the new mandate i.e., Clinical research on life-style related and noncommunicable diseases, the various activities of the Centre have highlighted in brief as below.

- 1. Out Patient Department: A total number of 2615 patients were treated, out of which 946 were male, 1669 were female. In geriatric OPD a total number of 560 patients were being benefited by taking the treatment out of which, 106 were male and 454were female patients. In Specialty 'Flu like illness' OPD a total number of 142 patients were treated in which 56 were male and 86 were female.
- 2. Clinical Research Projects:Continuing IMRClinical trial entitled 'Clinical evaluation of *SukumaraGhritam* and *BrahmiChurnam* in the management of Menopausal Syndrome' in which total number of 18 patients were screened, 17 participants have been enrolled along with 6 patients who have completed the trial.

# 3. Outreach Activities:

i) 'Tribal Health Care Research Project (THCRP)' Under this project, 44tribal villages were covered in 206 tours along with covering **7918** population. Treatment provided to **3413** patients, investigations were also carried out for 548 patients (HB% - 256 & RBS-292) and were also documenting 15 folklore claims.

ii) 'Ayurveda Mobile Health Care Programme under Schedule Castes Sub Plan (SCSP)'. Underthis project 10 areas/villages were covered in 250 tours with 11065 population covered. Treatment provided to 5222 patients and Blood investigations also carried out to 1754 patients (HB% – 553 & RBS – 1201).

iii) SwasthyaRakshanProgramme (SRP): under this project 5 areas/villages were covered in 237 tours and 9700 populationwere covered. Treatment provided to 5618 patients along with Blood investigations of 620 patients (HB % – 222& RBS – 398)

# 4. Other Activities:

This centre had participated in several occasions like AROGYA Fair 2017- CHENNAI from 5 - 8 May, 2017.India International Science Festival 2017 (Mega Science & Industry Expo 2017) at Anna University- Chennai, Tamilnadu, from 13- 16 October 2017 and also organized a workshop on "Pain management through Ayurveda" on the occasion of National Ayurveda Day on 17 October 2017.During the reporting period 9 research papers were published in various National and International journals and there were 10 participation in different National/International/Departmental-Seminars/Workshops etc.

# 9. ACADEMIC ACTIVITIES

# 9.1 National Board of Examinations

The VHS Hospital is a recognised and accredited institution by the National Board of Examinations for courses in the branches of Neurosurgery, General Surgery and Obstetrics and Gynaecology.

The institution has arranged an excellent teaching faculty for these courses by utilising the services of experts in the respective branches, who are having rich experience in post-graduate teaching, from Government and Non-Government institutions.

There has been exchange of students from other major accredited institutions (like Public Health Centres, the Railway Hospital, etc.) Many CME programmes, panel discussions, symposia with journal clubs, and workshops are being conducted in the hospital in order to update the academic knowledge of Diploma National Board (DNB) students. The students are also deputed to such programmes conducted in other institutions.

#### **<u>Schedule I</u>** Significant Accounting Policies and Notes on Accounts

#### **Statement of Significant Accounting Policies:**

a. Accounting Convention:

The accounts are drawn up on historical cost basis and have been prepared in accordance with the generally accepted accounting principles in India.

b. <u>Revenue Recognition:</u>

All incomes and expenditures are accounted on cash basis. Income from earmarked funds is directly credited to respective Project/Earmarked Funds Accounts.

- c. Fixed Assets and Depreciation:
  - i) Fixed Assets are stated at historical cost less depreciation.
  - ii) Depreciation on Fixed Assets is charged under Written down Value
    - as per the Income Tax Act except Buildings on which 5% depreciation is claimed .
  - iii) Pro rata depreciation is provided on additions to Fixed Assets.
- d. Inventories:

Inventories are Valued at cost or net realizable value whichever is less.

#### Notes on Accounts;

a. Project Accounts:

All incomes relating to Project Accounts are directly shown under Project Receipts and all expenditure including Capital Expenditure are shown under Project Payments Account. The total Capital Expenditure on Project Accounts during the year is Rs.0.51 lakh on which no depreciation is claimed.

b. Investments:

All the Investments are in Fixed Deposits with Nationalised Banks and State/Central Government Undertakings.

c. <u>Contingent Liability:</u>

Claims against the institution towards salary arrears not acknowledged as debts. The quantum of liability in respect of labour cases is determinable only on receipt of judgments in the pending cases in court.

d. Previous year's figures have been re-grouped or re-classified wherever considered necessary to make them comparable with those of the current year. Figures have been rounded off to the nearest Rupee.
